

LAKE NEWS

Lake Conditions. With the drought conditions and high summer temperatures this year, controlling vegetation growth has been a tough battle for Danbury Lake Management. Danbury is on the lake about every I-2 weeks, spraying the vegetation to try and keep it under control. As the temperatures have begun to drop, we are seeing better results from these lake treatments as the chemicals are more effective. The vegetation has started to die back. The hope is that the prediction of a wet winter comes true, and the lake will fill up and cover this vegetation that is dying back and starting to sink.

Fish Stocking. We started the year with the intent of stocking fish in the spring and in the fall. We completed the first fish stocking at the end of April and also released approximately 250 lbs. of crawfish in that same timeframe. The second stocking that would have been performed in the fall, was not completed because of the low water conditions. The current plan will be to complete the additional fish stocking some time in 2024.

Holiday Boat Parade and Celebration. At the time of writing this article, the expectation is that we will not have a holiday boat parade this year. The lake level is currently approximately 3 feet low. A lot of boats are docked on dry lake bottom. If we happen to have a very large rainstorm before Christmas that significantly raises the lake, then we will reconsider having this parade and celebration.

LANDSCAPING NEWS

The summer's extreme heat is finally behind us, and we have a brief window to take care of our final plantings for 2023 before it is too cold. Our winter seasonal color change is currently taking place. The Landscape Committee chose a mixture of red, white, and pink dianthus on a background of white snapdragons. In our larger beds that have 3 varieties of flowers, blue matrix violas will be our short border plants. This combination is very similar to what was planted last winter.

The flowerbeds on the front and back ends of the Harvester Lane median at Lake Olympia Parkway have recently been updated to replace dead and missing plants. The median bed inside the gate at Flamingo Island has also been updated. That bed was paid for with funds from the extra assessment that Flamingo Island residents pay each year. Numerous plants will soon be added to the beds behind the gatehouse on Island Boulevard near the marina.

Many of the new plants that were installed around our community last spring died from the summer's 100+ degree temperatures and the lack of rain. We are in the process of replacing those plants since they are still under warranty. It's also time to install mulch throughout Lake Olympia. That is done twice a year.

Upcoming projects include improvements to the beds on both ends of the roundabout at Pond Brook at Crow Valley. The landscaping on the median on Crow Valley just north of Lake Olympia Parkway will soon be refurbished. The dying Ligustrum trees will the replaced with crape myrtles, and the flowerbed at the back end of the median will be completely redesigned and updated. Two groups of 10 dead and dying Ligustrum trees on Lake Olympia Parkway near the clubhouse will be removed and replaced with blue flowering vitex, or chase, trees.

We try to focus first on the areas around Lake Olympia that are the most in need of attention. If you have a flowerbed near you that needs some TLC, please contact Management so they can pass the information on to the Landscape Committee.

COMPLIANCE CORNER

"What's in a Name?" ACC = EMR

Fans of Shakespeare will recognize this quote that occasionally pops up in everyday conversation. As a refresher, the saying means a name is simply something to identify a person or thing - by itself, the name has no worth or meaning.

In the case of Lake Olympia Civic Association and Architectural Control, the name really does mean something important, especially considering our transition to the new management company. Crest will be our managers going forward and they have a great system for what we have historically called "architectural control change requests or ACC requests".

The ACC system is fully online and allows homeowners themselves to upload requests and necessary documents. This is a great improvement over our old system where all requests had to run through the on-site manager to start the process. Now, office staff will only have to review already uploaded requests, and if complete, they will approve it quickly to go to the Architectural Control Committee for review.

So, "what's in a name?" On the new website, the link to upload requests is called an "Exterior Modification Request or EMR". In smaller print you'll find the more familiar Architectural Control or ACC request, but we want to be sure residents aren't thrown off by that new Exterior Modification Request label when you look for the upload link.

Our transition to Crest has been very positive and we expect things to continue to go smoothly. Nothing has changed in requirements for modification or other requirements, only "the name"!


