LATE WINTER LANDSCAPING NEWS

Spring is almost here and hopefully there isn't another killing freeze in the weather forecast. Our landscaping service, Superior LawnCare, did a great job of covering our most cold sensitive plants with frost cloth during last month's freezing temperatures. Frost cloth can't prevent all damage to tender vegetation, but it can keep those plants from dying and can encourage perennials to come back faster.

Much of January and February has been spent determining the location of dead and missing plants all around Lake Olympia and creating proposals for replacing them. We want to be able to start filling in the empty spaces in our flowerbeds as soon as the danger of a freeze has passed. If you have plants in your area that need replacing, please let Management know so they can pass that information on to the Landscape Committee.

The Landscape Committee is currently selecting the flowers to be planted for our spring seasonal color, as well as those that will be installed in the middle of the summer. Lake Olympia has 3 seasonal color changes each year.



THE LATEST NEWS FROM THE LAKE COMMITTEE

Hello everyone. We appear to have made it through the winter with a full lake. Let's hope this year we don't experience the drought of 2023 that led to very low water levels, and difficult conditions for managing the lake. Due to those low water conditions, we were able to only get in one boat parade last year, but unfortunately could not have our holiday parade and celebration.

As the weather begins to warm up, I assume more people will be considering buying a new boat. Please remember the following rules: Boat Length (Max. I 8ft.), Width (Max. I 0 ft.), and motor HP (Max. 8 HP). All boats must be registered at our onsite office before entering the lake. I would strongly suggest you contact me before purchasing a boat, so we can verify everything on your boat. If you have any questions about purchasing a boat, please contact Gary Leist.

Last year we solicited donations for stocking the lake. Approximately \$6,380 was pledged. Of that amount, we spent approximately \$3,000 last spring. We did not have a follow-up fish stocking in the fall because of the low lake levels. With the remaining funds we will look into an additional fish stocking this year. Danbury Lake Manage also gave us approximately 400 small fingerling bass in December when they cleaned out some of their stock tanks at yearend.

I ask everyone who uses or lives on the lake to do their part to preserve our environment. Do not use weed and feed or harsh chemicals near the lake. Boat users should maintain a speed so as not to create a wake that stirs up lake sediment or erodes the shoreline. Lake front residents should not clearcut vegetation on the shoreline which serves as habitat for shore birds. In fact, anyone living on a shoreline without a bulkhead, should not be trespassing into the MUD District property behind their homes to remove any tree(s), without having written permission from the MUD District or HOA. Vegetation may only be cut no lower than one foot, not including trees, and there shall be no substantial disturbance of the root systems of any vegetation in the District Wetlands.

COMPLIANCE CORNER

Trees and Architectural Control Committee Approval

Trees and landscaping are usually considered by homeowners to be an added value. Many years ago, the original developer set out the basics for yards and trees in Lake Olympia, and we still follow those rules today.

From time to time, the management company is asked for permission to remove a tree growing at a home. It may be a tree on the owner's lot or one next door. It is important to note that removal of any tree requires approval from the Architectural Control Committee in advance of any removal taking place. The request will go through the formal process, accessed through the website online, as an Exterior Modification Request (EMR) with the requirement to provide a plan to replace the tree, as well. Additional information from a certified arborist may be required to prove disease, if that's the reason for removal, or a full landscaping plan if a new design is proposed. Because a tree survey is done on each lot at the time a home is built, a request to remove a tree applies to all trees, front, back or side.

In Lake Olympia, all homes are required to have two trees in the front yard and if they are on a corner, an additional three trees on the side. The trees must be "hard wood" and most trees you see in our area are just that. One interesting thing to note is that palm trees are not considered hardwoods, even though you do see them in Lake Olympia. They can be put in place in addition to the hardwoods and can be used to create a nice landscaping design.

It is important to note that some sections of Lake Olympia have additional requirements, not just for trees, so always be sure to check the Lake Olympia covenants before moving ahead with plans. Our management representatives can assist with that process.

Trees are important to our community not just because they look good, but also because of the cooling shade they provide to our homes and the important work they do for our environment. Many are concerned these days about global warming and how we can help stabilize and rebuild the ozone layer. Trees are an easy way to help clean the air naturally and they provide the added benefits already discussed. To learn more about how trees benefit our environment, do an internet search for "trees and ozone reduction" to find a variety of sources for information.

Here in Lake Olympia, we really enjoy our trees, lakes, and natural surroundings. Let's work together and with the ACC to keep things beautiful!

LAKE OLYMPIA SWIM TEAM - TIGER SHARKS



Lake Olympia has hosted a swim team since 1988, providing fun for our children every summer from May to mid-July. It is a volunteer run organization and is open to children ages 5 – 18 years old. We are limited to 200 swimmers, so register early!

Coaches will work to improve technique in 4 strokes: Freestyle, Breaststroke, Backstroke and Butterfly. Young children are probably ready for the team if they are comfortable in the water and will take a few strokes on their own. At the end of the new swimmer orientation period, prospective members must be able to meet the following requirements:

6 and under – able to move in the water for one half length of the pool

7 and over – able to swim the full length of the pool

Note: This is a swim team, NOT a learn to swim team. Depending on staffing and numbers, some swimmers may be kept on a "practice team" if not ready for competition.

NEVER TOP TREES!

It's time to trim trees, so please inspect your front yard trees to see if they need trimming. Trees should have a clearance of 8 ft. over the sidewalks and 13 ft over streets. This is also a Missouri City ordinance.

We have noticed that some residents have "topped" their trees. Topping a tree is the removal of the upper main branches (top or canopy) and central stem of the tree. The result is an unsightly tree with thin upright small branches called water sprouts at the top. Topping trees is not allowed in Lake Olympia as topping a tree seriously affects its health and makes the tree susceptible to disease, decay, and insects. In addition, topping permanently disfigures and damages the tree and may even kill it. Once a tree is topped, it can never be fully restored.

Crepe Myrtles: Crepe Myrtles should never be pruned in the same place every year. Big ugly knuckles or knots form on the end of the branches and disfigure the tree. This is referred to as "crepe murder". Topping not only destroys the natural beauty of the tree but can leave is susceptible to disease and infection. You must only prune a few inches above where you pruned the tree the year before.
